**NOTICE OF INTENT  
TO ADOPT A MITIGATED NEGATIVE DECLARATION**

**NOTICE IS HEREBY GIVEN** that the Sacramento Area Flood Control Agency (SAFCA) (a) has concluded after preparing an Initial Study that the Bryte Landfill Remediation Project (Project) would not have a significant effect on the environment with implementation of mitigation measures described in the Initial Study; (b) has prepared a proposed Mitigated Negative Declaration (MND) for the Project; and (c) anticipates recommending to the SAFCA Board that it approve the MND.

**PROJECT:** Bryte Landfill Remediation Project

**PROJECT LOCATION AND DESCRIPTION:** The project is located in the Lower Elkhorn Basin approximately 1 mile north of West Sacramento in Yolo County, within the Sacramento West USGS 7.5-minute quadrangle. SAFCA proposes to clean up the Old Bryte Landfill (Landfill) to allow unrestricted future use of the Landfill property. The Old Bryte Landfill is contained on the Hazardous Waste and Substances Sites (Cortese) List. The proposed project would completely remove and relocate all waste material in the Landfill, any impacted sediment within the drainage canal on the north side of the Landfill, and native soil underlying the waste that contains constituents of concern exceeding the remedial goals. Excavated material would be relocated to a Corrective Action Management Unit on contiguous property approximately 1,700 feet north of the Landfill, with construction and demolition debris disposed at the Yolo County Central Landfill.

**DOCUMENT REVIEW AND AVAILABILITY:** The 30-day public review period begins on August 14, 2017, and ends on September 12, 2017. A copy of the Initial Study/proposed MND is available for public review at the following locations:
