

AMENDMENTS TO CONTRACT DOCUMENTS

VOLUME 1, SPECIAL PROVISIONS

1. Special Provisions

A. Add Paragraph SP-39 as follows:

“SP-39 ADDITIONAL INSUREDS

Modify General Specifications, paragraph 309.04F, Other Provisions to include the following provision:

1d. Lee A. Moulton and Eleanor A. Moulton, Trustees of the Lee A. Moulton and Eleanor A. Moulton Revocable Trust Established June 2, 1986; Gregory H. Moulton, and Alycia Moulton and their tenants shall be covered as additional insureds as respects liability arising out of the activities performed by or on behalf of the Contractor, premises owned, occupied, or used by the Contractor, or automobiles owned, leased, hired, or borrowed by the Contractor. The policy shall contain no special limitations on the scope of coverage afforded to Lee A. Moulton and Eleanor A. Moulton, Trustees of the Lee A. Moulton and Eleanor A. Moulton Revocable Trust Established June 2, 1986; Gregory H. Moulton, and Alycia Moulton and their tenants.”

B. Add Paragraph SP-40 as follows:

SP-40 IDEMNIFICATION

Modify General Specifications, paragraph 6-2.02 as follows:

“To the fullest extent permitted by law, Contractor shall indemnify, defend, and hold harmless Agency, the State of California Central Valley Flood Protection Board, State of California Department of Water Resources, Reclamation District No. 1000, State of California Department of Transportation, Natomas Central Mutual Water Company, County of Sacramento, County of Sutter, and City of Sacramento, their respective governing Boards, officers, directors, officials, trustees, employees, agents, and volunteers and Lee A. Moulton and Eleanor A. Moulton, Trustees of the Lee A. Moulton and Eleanor A. Moulton Revocable Trust Established June 2, 1986; Gregory H. Moulton, and Alycia Moulton and their tenants, (“Indemnified Party”) ...”
