SUBJECT: EXECUTIVE DIRECTOR'S REPORT FOR DECEMBER 21, 2017

Federal FY 2018 Appropriations Update

The Federal Fiscal Year (FY) 2018 started on October 1, 2017. Congress was unable to pass appropriation bills for FY 2018 prior to October 1st, and consequently, passed a Continuing Resolution (CR) until December 8, 2017. With negotiations nearly to the eleventh hour on December 8th, the Congress averted a Federal government shutdown and agreed to a 2-week stopgap funding measure through December 22nd. Nonetheless, the agreement is a temporary reprieve, because it is likely that final FY 2018 levels won't be decided until early next year. The CR again extends the National Flood Insurance Program, making it a virtual certainty that a multi-year authorization will also be deferred to next year.

Assistant Secretary of the Army for Civil Works

As previously reported, President Trump has nominated R.D. James to be the Assistant Secretary of the Army for Civil Works. Mr. James has most recently served as a civilian member and engineer on the Mississippi River Commission. On November 14, 2017, the Senate Armed Services Committee advanced his nomination. On December 6, 2017, the Senate Environment and Public Works (EPW) Committee held its oversight hearing on the nominee. The White House's pick to lead the U.S. Army Corps of Engineers is now headed to the Senate floor after his nomination cleared the EPW Senate committee Dec. 13, 2017.

Principal Deputy Assistant Secretary of the Army (Civil Works)

Mr. Ryan A. Fisher was appointed Principal Deputy Assistant Secretary of the Army (Civil Works) on November 6, 2017, and is serving as the Acting Assistant Secretary of the Army (Civil Works). As Principal Deputy to the Assistant Secretary he provides policy and performance oversight for the U.S. Army Corps of Engineers Civil Works program.
